

After lunch at the hotel, we'll visit the Austrian Mint, housed in a magnificent building in the heart of Vienna since the early 19th century. The beautifully crafted coins minted here--including the rare 175th-anniversary Vienna Philharmonic Orchestra commemorative 20-euro silver proof coin--are highly sought after by investors and collectors all over the world. Internationally renowned for its precious metal processing, the mint has 800 years of coin-making experience and produces 450 million coins a year. Their production includes some of the world's best-selling bullion products.

We'll get to see--and purchase--the commemorative anniversary coin displaying the golden emblem of the Vienna Philharmonic, and the three main founding fathers of the orchestra: Otto Nicolai, August Schmidt and Alfred Julius Becher. Then it's off to the Kunsthistorisches Museum, where a private tour takes us through the remarkable *Kunstammer* exhibit, the most important art collection of its kind in the world.

Tonight, enjoy a spellbinding chamber music concert.

TERMS AND CONDITIONS

PAYMENT POLICY: A deposit of \$500 per person is due to secure your reservation. The balance of payment is due by August 31. After August 31, 2017 space is available on a first-come, first served basis and full payment is due with reservation.

CANCELLATION POLICY:

Cancellation fees for LAND PACKAGE per person are as follows:*

From time of reservation until August 31, 2017:	\$ 300.00
From August 31-September 27, 2017:	25% of the tour cost is non-refundable
From September 28-October 27, 2017:	50% of the tour cost is non-refundable
From October 28 to day of departure:	NO REFUND

Penalties apply on a per-person basis and are calculated from the date written notice of cancellation is received by AESU.

****Above restrictions apply to land tour package only. Flight reservations are separate and carry separate cancellation penalties, to be detailed at the time of reservation.***

All cancellations must be received by AESU in writing. Date of receipt will determine penalties assessed. No show also means no refund. We strongly advise that passengers take out TRIP CANCELLATION INSURANCE. AIRFARES are highly restrictive, NON-REFUNDABLE, NON-ENDORSABLE and NON-TRANSFERABLE once ticketed. Once reservation is booked and paid for AESU reserves the right to issue tickets. Once ticketed, there is no refund on airfare portion.
